## 11:00 AM BUSINESS SESSION MINUTES

**PRESENT:** Commission Chairman William Mounger, Commissioners Bill F. Cossar, Scott Coopwood, Leonard Bentz, and Gary Rhoads.

The Chairman welcomed guests watching the live stream video and special guests attending; U.S. Forest Service attendees (Mike McDonaldson, Tony Bolton, and Shannon Kelardy); Texas Department of Wildlife and Fisheries, John Kinsey; Kristen Windham, Governor Tate Reeves' Office; and the Honorable Chuck Younger, Mississippi State Senate.

## **OPENING PRAYER**

Russ Walsh, Wildlife Chief of Staff, opened the meeting with prayer.

#### **MINUTES**

ACTION: Upon motion by Commissioner Cossar and seconded by Commissioner Coopwood, the Commission meeting minutes of March 16, 2022, were unanimously approved.

#### **AGENDA**

ACTION: Upon motion by Commissioner Coopwood and seconded by Commissioner Cossar, the Commission unanimously approved the meeting agenda of April 21, 2022.

#### **LICENSE SALES REPORT**

Jason Thompson, License/Boat Registration Division Director, presented the License Sales Report for the month of March 2022. The total revenue for the end of March is up around \$230,000 compared to March 2021.

Highlights of his report are listed below:

- Resident license sales down 1.75%
- Non-resident license sales up by 4%
- Other Licenses down 1.7%
- Lifetime License category down 6%

License packages are up 1,647 compared to 1,478 sold last March 2021.

## **PUBLIC COMMENTS**

## Davy Murrah - Pascagoula River WMA.

Mr. Murrah wanted to thank the Commission for taking his comments seriously last September 2021. MDWFP biologists and Executive staff met with him on October 28<sup>th</sup> on the sandbar at Pascagoula River WMA for two hours reflecting on needed changes and maintenance. Murrah recommended reinstating two managers at Pascagoula River WMA, instead of one, due to its size and needs. He inquired why the second manager position was advertised last month; yet no applicants were hired.

Chairman Mounger stated that the Commission will discuss this vacancy during Executive Session when personnel matters are taken into consideration. Mounger thanked Mr. Murrah for coming.

## **WILDLIFE**

## FINAL - 40 Miss. Admin. Code Part 2, Chapter 5 - Alligator

Ricky Flynt, Wildlife Alligator/Furbearer Coordinator, presented proposed changes and clarifications to Rule 5.2 – Private Lands Alligator and Rule 5.3 – Public Water Alligator; as well as a NEW Proposed Rule 5.4 for Pelahatchie Bay Alligator Season at the March Commission meeting.

Flynt informed the Commission that no negative comments had been received this past month and recommended Final Approval.

ACTION: Commissioner Rhoads moved to approve FINAL Rules 5.2, 5.3, and 5.4 as recommended by staff. Commissioner Bentz seconded the motion and the motion carried.

## Rules 1.1 - 1.46 - WMA Regulations

Russ Walsh, Chief of Staff, presented the following rule changes for each WMA as outlined in a handout distributed to the Commission. A summary of these changes is outlined below:

- Camping for Backwoods 4 is only allowed at Mahannah Campground.

Camping area language.

Change October to Open Archery opportunity.

## **LANGUAGE CLARIFICATION**

#### ORVs/ARVs - Rules 1.10 & 1.21

Lake George & Shipland – Delete ATV Trail wording to clarify there are no trails.

#### Phil Bryant WMA – Rule 1.46

- Delete "when environmental conditions and infrastructure are suitable for public access."
- Goose Lake ORVs/ATVs/Electric Bicycles are prohibited (No access off levee)
- Buck Bayou Deer harvested on Buck Bayou must be checked in at Buck Bayou Parking Area.
- Buck Bayou Visitors must park at Buck Bayou Unit parking area and cannot park at Backwoods unit campsites.

## <u>Yockanookany WMA – Rule 1.35</u>

o Close 10-acre area across Hwy 12 surrounded by houses.

Commissioner Bentz questioned why ten acres of public land would be closed. The attorney and MDWFP staff replied that these ten acres are surrounded by private homes. Safety and protection are the chief concern.

#### Howard Miller WMA - Rule 1.38

 Clarify scouting days are Sundays and Wednesdays and visitors must park at front entrance.

## Pascagoula River WMA - Rule 1.18

- Land Between the Creeks Clarify scouting days.
- Land Between the Creeks ORVs/ATVs are only allowed for retrieval. During Turkey Season, electric carts may be used on roads open to motorized vehicles.

#### WATERFOWL

#### Mahannah WMAs - Rule 1.12

- Woodcock and Snipe Season add working to clarify hunt days.
- Waterfowl Be out of assigned unit by 1 p.m.

## Charlie Capps and Deviney WMAs - Rule 1.40 & 1.41

- September Teal Open concurrent with statewide season. Hunt on any open water.
- Deviney WMA Geese open during early season.

ACTION: Upon motion made by Commissioner Cossar and seconded by Commissioner Coopwood, the Commission approved PROPOSED WMA Regulations (Rules 1.1 - 1.46), as recommended by staff. Commission Bentz was recorded as voting "No."

## PROPOSED - 40 Miss. Admin. Code Part 2, Chapter 2 - White-tailed Deer

Russ Walsh stated that Rule 2.2 was amended to reflect statutory changes made by the 2022 Legislative Session in House Bill 1035 which added a 3-day Velvet Deer Hunting Season.

## Rule 2.2 – White-tailed Deer Hunting Seasons and Bag Limits - Changes

- 1. .Velvet Season: Consecutive Friday, Saturday, and Sunday between September 10-20 on private lands and specified Wildlife Management Areas.
  - a. Archery: Longbows, recurves, compound bows, and crossbows. There is no minimum or maximum draw weight. There is no minimum length arrow. Fixed or mechanical broadheads may be used.
  - b. Only legal bucks for the respective Deer Management Unit may be harvested.
  - c. The bag limit is one (1) legal buck and count towards the annual antlered deer bag
  - d. Hunters (including license exempt hunters) must report their harvest by 10 PM the day of harvest. Hunters can report via the MDWFP smartphone application or MDWFP web portal.

- e. All hunters, unless exempt or have a lifetime license, must possess a valid Velvet Season Permit.
- f. All harvested bucks must be submitted for CWD sampling to a MDWFP CWD dropoff freezer or to an MDWFP participating taxidermist within 5 days of harvest.

ACTION: Commissioner Coopwood moved to approve staff recommendations on PROPOSED Rule 2.2, seconded by Commissioner Bentz, and the motion carried.

# <u>PROPOSED - 40 Miss. Admin. Code Part 1, Chapter 8 - General Regulations applicable to Sale and Types of Licenses to Hunt, Trap, or Fish</u>

Walsh proposed increasing the Non-Resident Deer Permit to \$50.00 to be in line with the \$50 Non-Resident Turkey Permit.

## Rule 8.4 – Non-Resident Hunting and Fishing License & Fee Program – changes

- F. License Types and Prices for Non-Residents
- e. Deer Permit Required for hunting deer during all deer seasons. This license must be purchases in addition to any all game, 7-day all game, or 3-day all game hunting license: \$50

ACTION: Commissioner Rhoads moved to approve staff recommendations on PROPOSED Rule 8.4, seconded by Commissioner Cossar, and the motion carried.

\*DUCKS, MERGANSERS, and COOTS daily bag limit and possession: The duck daily bag limit will include a total of 6 ducks, including no more than 4 mallards (no more than 2 of which may be females), 3 wood ducks, 2 redheads, 1 pintail, 2 canvasbacks, 1 mottled duck, and 2 black ducks. The daily bag limit for scaup is 1 scaup per day Nov. 25 - 27, Dec. 2 - 4, and Dec. 9 - 17; and is 2 scaup per day Dec. 18 - 18 Jan. 18 - 18 Jan.

Commissioner Bentz asked if we could appeal Washington for later duck hunting dates in Mississippi. Chairman Mounger informed him that the Mississippi Flyway Council worked to get the closing date for duck season extended to January 31, in recent years. Chairman Mounger added that the U.S. Fish and Wildlife Service has been resistant to having the season run later due to the ducks having pair bonds formed by that time of the year.

#### **FISHERIES**

Jerry Brown, Director of Fisheries, presented the following PROPOSED rule changes.

## PROPOSED 40 Miss. Admin. Code Part 3, Chapter 1 – General Fisheries Rules

- Rule 1.3 Regulations regarding Sport Fishing
  - A. Adopted rules and regulations
    - 1a. Clarifies that it is illegal to set trotlines that extend more than halfway across a stream, channel, drain, or other body of water.
    - 3e. Clarifies that no more than two artificial lures can be used in spillways where hook restrictions are in place.
  - C. Crawfish and freshwater shrimp
    - 4a. Adds that puddle nets and life nets are allowed for catching crawfish.
  - F. Adds that written permission is needed to run someone else's fishing gear.

ACTION: Upon motion made by Commissioner Cossar and seconded by Commissioner Bentz, the Commission unanimously approved PROPOSED Fisheries Rule 1.3, as recommended by staff.

# PROPOSED 40 Miss. Admin. Code Part 3, Chapter 2 – State Fishing Lakes, and Community Fishing Assistance Program Lakes

- Rule 2.1 Regulations regarding State Fishing Lakes
  - Other rules.
    - 5d. Sets waterfowl hunting days at Lake Bogue Homa to Wednesdays, Saturdays, and Sundays with shooting time ending at noon.

Brown informed the Commission that this change was the result of comments received from hunters and staff. The intent was to give the birds some relief by ending at noon and having set hunting days.

ACTION: Upon motion made by Commissioner Cossar and seconded by Commissioner Coopwood, the Commission approved PROPOSED Fisheries Rule 2.1, as recommended by staff. Commission Bentz was recorded as voting "No."

## **PARKS**

## Parks Update

Andre Hollis, Director of Park Operations, presented the following revenue update on Parks comparing February FY21 to February FY22:

- Reservations (Camping, Cabins, Primitive) Up \$66,126
- Entrance and Miscellaneous Privilege Fees Up \$16,722
- Gross Revenue Up \$1,551,561

Hollis informed the Commission that the Beach Campsite Project had been completed with the demolishment of 70 grass and gravel beachside sites and 44 gulf view sites created with concrete pads and full water/sewer hookups. The price increases compare to other campsites in the area. There are no price increases for the other 206 campsites, which are currently \$32/night.

# Law Enforcement Update

Col. Jerry Carter, Chief of Law Enforcement, reported 460 citations issued for the month of March with "No License" being number one and "Trespassing" was number two.

Officer detail included investigating illegal turkey hunting in Jefferson Davis County and encountering the subject sitting in a camouflage ground blind near a feeder filled with cracked corn chops. The subject was cited for Hunting Turkeys with the Aid Bait under State Statute 49-7-101.

Officers also conducted compliance checks on WMAs throughout the State. Thirteen cadets recently graduated from the Mississippi Law Enforcement Officers Training Academy. Cade Brandon Clark graduated Top Cop of Class 267.

Shooting range customer counts are: McIvor – 801; Turcotte – 524; and McHenry – 527.

#### OTHER BUSINESS

#### **Executive Order – Wolf Lake**

Drew Malone, Special Assistant Attorney General, informed the Commission that pursuant to the authority set forth in MISSISSIPPI CODE ANNOTATED §59-21-111 et. seq., the Executive Director of the Mississippi Department of Wildlife, Fisheries, and Parks, on March 22, 2022, had suspended all recreational boating activity on Wolf Lake, in Yazoo County, Mississippi, due to the emergency flooding situation that existed along the Mississippi River. In order to protect and ensure the health, safety and welfare of the general public, and to protect private property, any boating was restricted to a "Dead Slow; Leave No Wake," standard. Since that Order was issued and prior to the Commission meeting, the water has receded; however, for informational and related purposes, the Commission is requested to ratify the executive action as taken earlier in the month.

ACTION: Upon motion made by Commissioner Bentz and seconded by Commissioner Cossar, the Commission unanimously ratified the Executive Order for temporary suspension of all recreational boating activity at Wolf Lake, Yazoo City. A copy of the Executive Order has been appended to the minutes.

There being no further items for discussion in Executive Session, Commissioner Bentz made a motion to open the meeting. Commissioner Rhoads seconded the motion and the Commission voted unanimously to open the meeting.

Mr. Malone announced to those individuals located outside the Commission room that the meeting was now open and that during Executive Session the Commission voted on three names to be submitted to the Governor for his consideration to fill the vacant Executive Director position, as per the requirements of Mississippi Code Annotated §49-4-6(2).

## MISSISSIPPI DEPARTMENT OF WILDLIFE, FISHERIES, & PARKS

In Re: Suspension/Closure of Recreational Boating activity during temporary high water emergency.

## **EXECUTIVE ORDER**

PURSUANT to the authority set forth in MISSISSIPPI CODE ANNOTATED '59-21-111, the Executive Director of the Mississippi Department of Wildlife, Fisheries and Parks, with the approval of the Commission, has ordered the suspension of all recreational boating activity on the lake or lakes listed below, due to emergency flooding and high water resulting from unusually heavy rainfall events. This suspension of privileges applies *ONLY* to recreational boating and not to any boating activity that must be employed for the safe transportation of persons to and from a home or dwelling or other legitimate purpose. Any boating activity during the suspension period shall be conducted in a reasonable manner, minimizing any wake created, or otherwise conducted to minimize any negative effects on surrounding property. The lake or lakes set forth below shall remain closed to recreational boating only, until further notice:

# LAKE: Wolf Lake, Yazoo County, Mississippi

IT IS THEREFORE ORDERED, That the lake or lakes listed above shall be closed to recreational boating activity, in order to protect the health, safety and welfare of the general public, until further notice. Any boating shall be conducted according to a "Dead Slow; Leave No Wake," standard. Failure to comply with this order may subject an individual to criminal liability.

SO ORDERED, this the 22nd day of March, 2022.
