

December 5, 2023 Weekly Waterfowl Report

The following report is a compilation of public and private land reports and habitat assessments during the week ending December 5, 2023.

Jackson, MS – The second weekend segment of the 2023-24 duck season was met with relatively warm and rainy weather conditions. Some areas across the Delta received close to 1 inch of rain. Many wetland impoundments that are rainfall dependent were able to collect some much-needed runoff, but much more is needed. The consistent warm temperatures likely had little effect on pushing waterfowl further south. The long-range forecast shows more of the same for the coming weeks, with the highs being in the mid-50s and the lows in the upper-30s. However,

Wildlife Management Areas (WMAs) across the Mississippi Delta are still holding good numbers of ducks. The harvest reports from the past two weekends were relatively high considering the overall current weather patterns. Some areas are having great success with hunters averaging over 4 birds/hunter/day. Some private land managers reported an increase in harvest from the previous week. Harvest consisted primarily of Northern shovelers, wood ducks, gadwall, and teal. An increase in snow and greater white-fronted geese increased significantly across the state over the past week. Aquaculture ponds are beginning to hold higher numbers of northern shovelers and a variety of diving ducks.

The final segment of the regular waterfowl hunting season starts back on December 9th and will continue through January 31st. Our December aerial waterfowl survey is scheduled for the week of December 11-15th. As soon as the survey is completed, the results and distribution maps will be posted on MDWFP's website and released through social media.
