DOCUMENTATION NEEDED FOR EXEMPT HUNTING / FISHING LICENSE

The following specifies documentation needed for each exempt hunting/fishing license along with proof of Mississippi residency*.

- 1. Exempt Youth under 16 must send social security number and, to prove Mississippi residency*, parent's name and copy of their driver's license.**
- 2. Exempt Senior 65 and over must send proof of Mississippi residency* and age such as a copy of driver's license. May use birth certificate as proof of age along with social security number. If using social security number see residency requirements below.**
- 3. Exempt Land Owner must provide documentation that land is titled in his/her name and prove Mississippi residency*. Only residents whose name is on land deed are entitled to this exemption. Send copy of deed and driver's license for proof of residency*.**
- 4. Disabled Exempt must send current year certification of disability as described below along with proof of Mississippi residency*.**
 - A. Social Security Administration - must obtain current year disability letter from Social Security Administration stating 100% totally disabled. Individuals must obtain a disability letter from Social Security Administration each year. A copy of this letter must be submitted to purchase a Disability Exempt card.**
 - B. Veterans Administration - must obtain letter from VA stating 100% service connected disability.**
 - C. Railroad Retirement Board - must obtain letter from Railroad Retirement stating 100% disabled.**
 - D. Blindness - must obtain letter from physician on letterhead certifying legally blind. The letter does not have to be renewed yearly.**
 - E. Paraplegic or Multiple Amputee - persons who are paraplegic or multiple amputee are not required to show additional proof of disability.**

*** PROOF OF MISSISSIPPI RESIDENCY***

The following are considered when establishing Mississippi residency:

- A. Mississippi Driver's License**
- B. Copy of recent Mississippi Homestead Exemption**
- C. Copy of recent Mississippi State Income Tax**
- D. In the case of minors, domicile of parent or legal guardian is used as evidence of child's domicile.**
